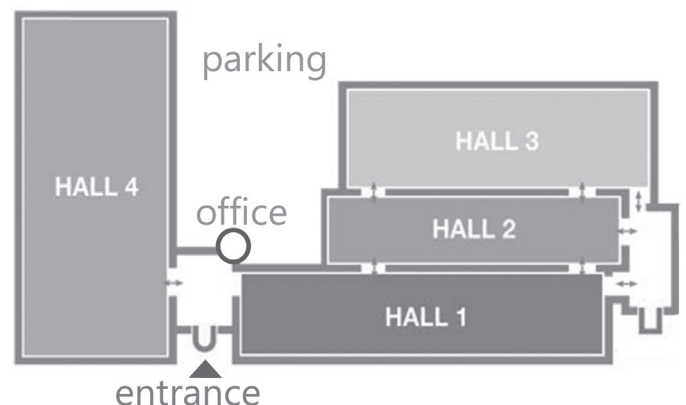

5 EXHIBITORS FEES

5.1 For exhibitors offering new parts, literature, model cars, maintenance materials, services (in hall 2): 30 € per sq.m.

5.2 Vehicle sale space for classic cars, value from 10.000 € (in hall 2): standard size stand (2,50 x 5,00 m): 295 € per stand.

5.3 For exhibitors offering used spare parts (in hall 3): standard size stand (4,00 x 2,50 m): 150 € per stand.

5.4 Vehicle sale space for classic cars up to 10.000 € (in Hall 3): standard size stand (2,50 x 5,00 m): 150 € per stand. Stand of 1,50 x 3,50 m (for motorcycles): 80 € per stand.

5.5 Vehicle sale space for classic cars, value from 10.000 €, new parts, literature, model cars, maintenance materials, services (in hall 4): 35 € per sq.m. Walls and carpets included. **Only wall stand areas.**

5.6 Stand locations for cars in Hall 4, according to module system, 35 € per sq.m.

5.7 Electrical connections (individual inspection included)

Orders for electrical connections must be placed by February 14th, 2016. In the event that an order is placed after this date a surcharge of 100 % will be added.

The installations on the stands should be in accordance with the applicable regulations, if they are not, the power supply will not be connected or will be cut temporarily or permanently.

Walls: it's strictly forbidden to drill holes, to drive nails into the walls or to paste stickers on the walls. Any damage will be charged for.

WiFi Connection: in Antwerp Expo is free Wifi.

The exhibitor's own **catering and dispensing systems** are only allowed on the stands following consultation with and approval by the organization. They can in no way compete with existing catering businesses. They should only be used and operated during the opening hours of the fair.

The **general smoking ban** in all indoor spaces at the Antwerp Expo applies at all times (both during assembly, during the fair and during dismantling) in compliance with the Law of December 22th, 2009 on a general system for smoke-free enclosed places accessible to the public and to protect workers from tobacco smoke. The general smoking ban is also necessary from the perspective of fire and insurance.

Dogs: are admitted to the fair only if they are carried by their carer. Exceptions are made for guide dogs.

VAT: all stand rental service costs, etc. are exclusive of VAT and will be charged in addition at the rate applicable at the time of delivery and performance by the organizer.

8 STAND PREPARATION AND FITTINGS

The stand areas booked by the exhibitor in the application form are prepared by the organizer. The exhibitor himself is responsible for the further equipping and fitting out of his stand.

The exhibitor should leave the stand in a clean condition after dismantling. All packaging materials etc. should be removed by the exhibitor, taken home or deposited in the waste container.

10 CONDITIONS OF PAYMENT

Fees calculated by the organizer are to be paid in full at least 10 days before opening of the fair. The exhibitor cannot occupy his stand area until he has paid their invoice.

11 WITHDRAWAL AND NON-PARTICIPATION

Stand rental fees are payable in all cases, even in those in which the exhibitor is prevented from participating in the exhibition for reasons outside their control. In well-grounded exceptional cases the exhibition managers are prepared to undertake an alternative leasing.

12 EXHIBITION SITE SECURITY AND CLEANING

The organisers arrange for the general security and cleaning of the halls (foyer, corridors, etc.) and exhibition site. The exhibitor is himself responsible for the security, cleaning and upkeep of his own exhibition area(s). Siha Salons Automobiles BVBA. can not be held responsible for theft, damage or vandalism to the exhibited vehicles, products or items.

13 INSURANCE AND RESPONSIBILITY

The exhibitor is himself responsible for the insurance of his exhibits and equipment. At night all valuable, easy removable objects must be put under lock and key. The organizer accepts no liability in this matter, nor do they accept liability for damages which may be adduced to structural defects, rain etc. The organizer have taken out liability insurance for their legal liability. The exhibitor is included in this insurance policy, but only on a subsidiary basis with regard to his own liability insurance. The liability insurance covers exclusively third party damages. Persons on the stand employed by the exhibiting company are not included. Nor does insurance cover extend to exhibition catering facilities or special services not operated by the organizer. All liability claims are to be reported promptly to the organizer.

14 ORAL AGREEMENTS

All arrangements, individual permits and special provisions are legally valid only when confirmed in writing by the organizer.

15 LEGAL VALUE AND PLACE OF PERFORMANCE

The legal value and place of performance of all obligations is Antwerp. Any claims against the organizer are to be made in writing four weeks after the end of the event at the latest, otherwise they will be held to have expired.

16 GENERAL CONDITIONS

The Antwerp Expo has householder's right for the exhibition centre in its entirety. House rules are valid during the exhibition.

Without accepting claims for damages the fair management is entitled to cancel the exhibition or to change the date, duration and/or opening hours. In case of cancellation the fair management will refund the rental charges, if already paid.

In the event of changing the date of the duration of the exhibition existing agreements are valid for the new date and new duration. Submitted applications remain binding for the exhibitors
